RECOMMENDATION:

Award Bid No. 120039-B-TK, Rip Rap to Youngquist Brothers, Inc. for the period February 7, 2012 through February 6, 2013, in the estimated annual amount of \$28,857.50 for Public Services Department.

BACKGROUND:

The purpose of this contract is to provide commercial grade 6"-12" rip rap for use at various pond locations throughout the City on an as-needed basis.

Pricing will remain firm for the initial twelve (12) month period. Any escalation in prices will be made on an annual basis thereafter by mutual agreement between the City and the Contractor. Adjustments shall be based on the U.S. Bureau of Labor Statistics, Employment Cost Index (ECI), Table 5 Compensation (Not Seasonally Adjusted): Employment Cost Index for total compensation, for private industry workers, by occupational group and industry) for the most recent 12 month period. In no event will the requested increase exceed 5%. This contract includes two (2) one-year renewal periods.
