SUBJECT: Award Bid No. 190043-B-JJ Craig Park Seawall Restoration

RECOMMENDATION:

Award Bid No. 190043-B-JJ Craig Park Seawall Restoration to Speeler & Associates, Inc., in an amount not to exceed \$260,840.00 for the Public Works Department.

BACKGROUND:

The project will address the reconstruction of several portions along the concrete walkway extending along Spring Bayou. Due to the deteriorating effects of both extreme high tides/severe weather events and natural historic exposure, several areas of the seawall and adjacent concrete-paved sidewalk have subsided/degraded and require necessary repair. Primary construction activities will include rehabilitation of several areas of seawall, cap as well as sidewalk replacement. The project also includes additional inspection and subsequent repair utilizing flowable concrete fill if deficiencies and or voids are discovered (see attached aerial view of project locations). The project is anticipated to be substantially complete within ninety (90) calendar days from Notice to Proceed.

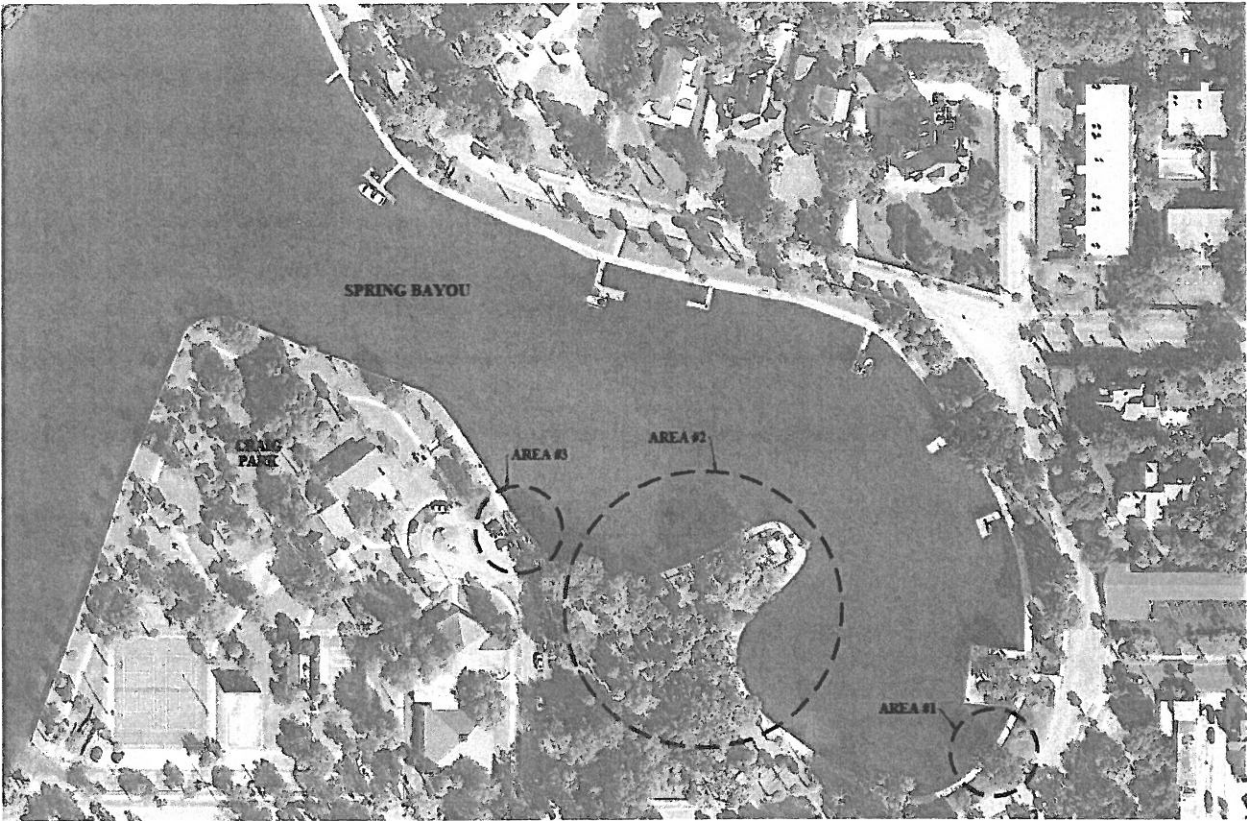
