AFFIDAVIT OF COMPLIANCE / ACKNOWLEDGEMENT					
 a. No more than four (4) hens per single family detached residence. No roosters, ducks, quail, geese, turkeys, pigeons, guinea fowl, peacocks, or similar fowl shall be allowed in districts not zoned Agriculture. b. Chickens shall not be allowed to roam freely (containment within a secured area or run is required) c. Coops and runs may not exceed six feet (6') in height and must be screened from the neighbor's view using an opaque fence. d. Coops and runs must be located at least ten feet (10') from rear and side property lines. Runs must be located at least five feet (5') from rear and side property lines. f. Coops and runs must be maintained in a safe, clean, condition. g. Slaughtering of chickens is prohibited. h. Chickens shall be kept for personal use only. Selling chickens, eggs, or chicken manure, or the breeding of chickens for commercial purposes is prohibited. i. Complaints of noise, odor, vermin, etc. will be treated as a nuisance violation. j. Violations of this section shall be enforced through Code Enforcement and may result in a daily fine for each day of the violation. k. Nothing in the City code shall prohibit Homeowners Associations from further regulating or prohibiting the keeping of chickens through homeowner restrictive covenants, deed restrictions, rules, or other similar regulating documents as provided for under Chapter 720, Florida Statutes. l. Complaints of animal cruelty and neglect shall be investigated in accordance with Florida Statutes. l. HEREBY CERTIFY THAT, AS A CONDITION OF APPROVAL, I FULLY UNDERSTAND AND ACKNOWLEDGE THE REQUIREMENTS STATED HEREIN AND AGREE TO ABIDE BY THEM AT ALL TIMES IN THE CONDUCT OF THIS PERMIT.
