#### RECOMMENDATION:

Rescind Award of Bid No. 200100-B-JJ Pent Street & Grosse Avenue Drainage & Roadway Improvements to Alto Construction Co., Inc. for reasons stated in the previous agenda item. Further, award the bid to American Pipeline Construction, LLC (American) in amount not to exceed \$3,205,757.50 for the Public Works Department.

#### BACKGROUND:

On May 26, 2020 the bid was awarded to Alto Construction Co., Inc. The project consists of the removal and reconstruction of roadway surface on Grosse Avenue between Tarpon Avenue and Live Oak Street. The new surface will be asphalt. Stormwater infrastructure is a significant part of the project including new and expanded stormwater management facilities, drainage conveyance additions, and a new outfall to the Anclote River. The project also includes new sanitary sewer and potable water infrastructure. The project is a Southwest Florida Water Management District Cooperative Funding Initiative project. The project is anticipated to be substantially complete within five hundred forty (540) calendar days from Notice to Proceed. American has been contacted and is prepared to begin work for their original bid price as soon as the Notice to Proceed is issued.
