Re:	Special Event – Tarpon Springs Merchants Association 32 nd Annual Sponge Docks Seafood Festival November 12, 13 & 14, 2021

Recommendation:

That the Mayor and Board of Commissioners approve the location revision of the "32nd Annual Sponge Docks Seafood Festival". The new location will be: Athens Street (Dodecanese Blvd. to Mill St.), Cross St. (Athens to Sponge Exchange parking lot entrance), Maragos St. (Athens St. to Hope St.; alley next to Costas Restaurant) and sidewalk area on Dodecanese Blvd. (in front of sponge diver statue and Sponge Exchange).

If a change in the event date is necessary due to inclement weather, the City Manager will authorize/designate a rain date.

Background:

All other aspects of the event will remain the same as approved by the BOC on May 11, 2021.

The reason for the location change is outlined below by the event sponsor.


