Recommendation:

That the Mayor and Board of Commissioners approve the JLP Forever special event application for "Joe Pappas Memorial Music Fest" on December 17, 2022 on Cypress St. (Pinellas Ave. to Hibiscus St.).

If a change in the event date is necessary due to inclement weather, the City Manager will authorize/designate a rain date.

Background:

This new event has been approved by the Special Events Review Committee.

This is a charity concert benefit to raise money for the National Alliance on Mental Illness. The food trucks will be placed on Cypress St., and will not impede on the one driveway on the street. The road closure will be between the hours of 3:00 p.m. to 1:00 a.m. The music and alcoholic beverages will be located on St. Nicholas Community Center property.

All set-up and clean-up will be the event sponsors, JLP Forever's responsibility.

Approval of this event authorizes the sponsor/user the use of City property for said special event with the understanding that they must operate and carry out the needs and functions of the event within the confines and requirements established and approved by the Special Events Committee, the B.O.C and the sponsor's application on record.
