Nijhuis Vertical Turbine Effluent Pump and Motor Packages

#### RECOMMENDATION:

Approve File No. 230134-N-AS, Single Source Purchase of 30 hp Fairbanks Nijhuis 13H Vertical Turbine Effluent Pump and Motor Packages to Barney's Pumps, Inc., in an estimated total amount not to exceed \$175,312.00, for the Public Services Department – Wastewater Treatment Facility (WWTF).

### BACKGROUND:

FUNDING:

The purpose of this contract is to replace four (4) Fairbanks 13H vertical turbine effluent pumps and motors (VTPs) located in the ground storage pump station. These pumps are required to transfer filtered effluent from the ground storage pump station to the chlorine contact chamber for effluent disinfection. The City's existing pumps and motors were installed 30+ years ago during the WWTF reclaimed water upgrade and require replacement (see attached memo). The Fairbanks VTPs have provided the best longevity of any pumps used at WWTF. Replacing them with Fairbank OEM VTPs minimizes pump station modification expenses, saves money on critical spare parts inventory, and will yield the best return on investment for the City.

Barney's Pumps, Inc., is the sole distributor serving the municipal market in the State of Florida (exclusive of the panhandle counties west of the Apalachicola River). A Notice of Intent to Single Source was noticed on DemandStar and no challenges were received. This project was identified in the existing 10-year CIP and is a planned equipment replacement.

## Recommendation

Authorize single source purchase of four replacement 30 hp Fairbanks 13H Vertical Turbine Effluent pump/motor packages for the wastewater treatment facility from Barney's Pumps Inc. totaling \$175,312.00.

## **Background**

The wastewater treatment facility currently utilizes four 30hp Fairbanks 13H Vertical Turbine Pumps (VTP's) located in the ground storage pump station. These pumps are required to transfer filtered effluent from the ground storage pump station to the chlorine contact chamber for effluent disinfection and identified in our existing FDEP domestic wastewater operating permit. The pumps/motors were installed in the early 1990's during the advanced wastewater treatment facility reclaimed water upgrade. The Fairbanks VTP's have provided the best longevity of any pumps used at the wastewater treatment facility and require replacement at the end of their useful life.

This project was identified in the existing 10-year CIP and is a planned equipment replacement. Purchasing original equipment replacements minimizes our expenses with pump station modifications and allows for cost saving with critical spares parts inventory. Barney's Pumps Inc. is the single source municipal supplier located in Florida.

### **Funding**

Funds have been budgeted in the water and sewer enterprise fund, Sewage Treatment account 402-4603-536.6300 in the 2023 Fiscal Budget.
